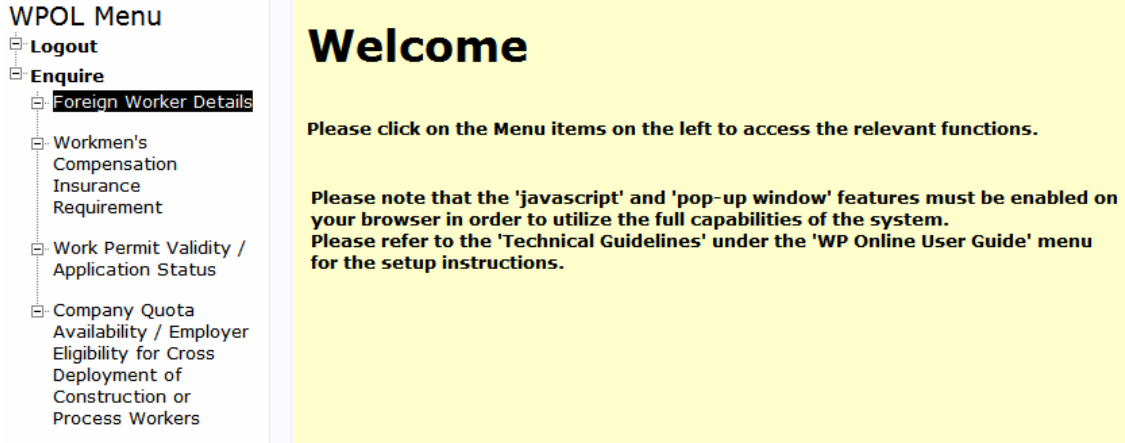

STEP 2: Click 'Foreign Worker Details'

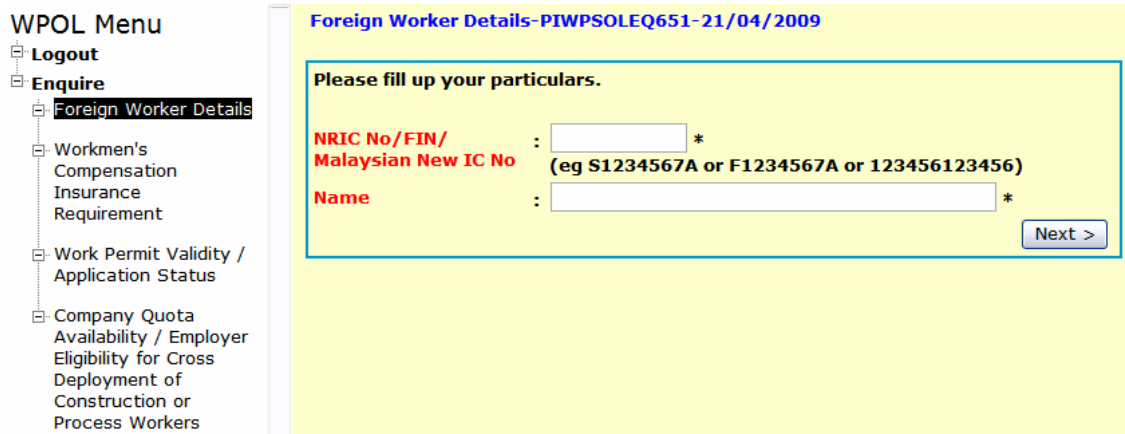
